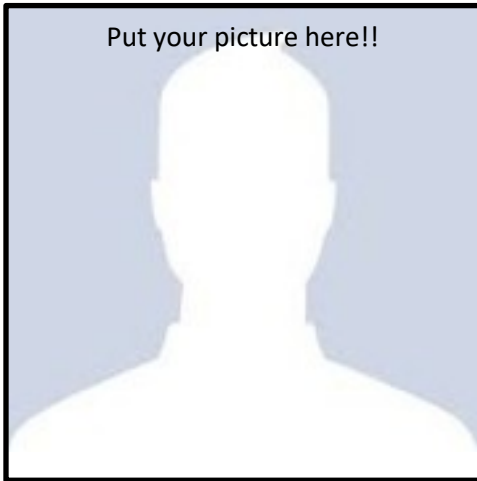

Statement of Eligibility

If elected a member of Student Council, you will be expected to maintain the following standards:

- 1) Academic: Members of Student Council must maintain good academic standing. Students with a current grade point average below 2.000 are strongly encouraged NOT to run.
- 2) Behavioral: Members of Student Council are expected to demonstrate the good conduct expected of a leader in a Christian community. If a member of Student Council is suspended from school (either in-school or home suspension) for any disciplinary reason, he or she will be removed from Student Council for the duration of the school year. Members may also be removed for any gross misconduct outside of school at the discretion of the Student Council Advisor in consultation with the school administration. Proper behavior also includes the maintenance of an active worship life in the member's home congregation.
- 3) Responsibility: Student Council members are responsible for representing the interests of the members of the student body. Attendance at Student Council meetings, committee meetings, and all Student Council functions is required unless an excuse is obtained in advance from the advisor. Poor attendance at school, excessive excused or three unexcused absences from Student Council functions will be cause for removal from office. Students with personal schedules that will consistently conflict with Student Council activities are strongly encouraged NOT to run. Specific responsibilities include the following: active participation on committees that meet during meeting times, attendance at one after-school meeting per month, and attendance at all Student Council sponsored events. Student Council members are also responsible for the specific duties required by the office they hold.
